The regular meeting was called to order at 8:20 p.m. Mr. Haile led those present in the Pledge of Allegiance.

CALL TO ORDER

Mr. Haile welcomed Gina Piskin to the Board again and acknowledge former Board member Susan Schwartz who is in the audience tonight.

Mrs. Lanci moved that the Board of Education approve the minutes of the August 5, 2015 Board of Ed regular meeting. Mrs. Blane seconded and the motion was carried 8-0.

MINUTES

Mrs. Goller moved that the Board of Education approve the Treasurer's report dated July 31, 2015. Dr. Kaplan seconded and the motion was carried 8-0.

TREASURER'S REPORT

Mr. DeTommaso welcomed everyone and asked the six principals to give a brief synopsis of the first day of school. Ms. Poppe, Kennedy HS, stated it was hot but fun. Orientation was great and the first day went smoothly. She thanked all the staff. Ms. Hollings, Calhoun HS, said it was a fabulous start, full of energy and exciting. Mrs. Ellinghaus, MAP, said MAP welcomed

new students and new classes. Mr. Harrington, Mepham HS, stated he was happy to see smaller class sizes and the new Broadcasting program. He's looking forward to a great school year. Ms. Johnson, Merrick Avenue MS, stated Day 1, Year 2 was a scene from a Disney movie. It was perfect and the kids were energetic, connected, lively and comfortable. Mr. Conte, Grand Avenue MS, stated he was happy to see new students make connections through shared experiences. He complimented the staff on their nurturing nature and added that the new hires have already made an impact.

Mr. DeTommaso added kudos to everyone for getting things ready. He thanked Tom Volpe, Transportation, for ironing out first day wrinkles and Jon Simpkins, Buildings and Grounds, for having everything ready to go which made a smooth opening.

BOND UPDATE

Mr. DeTommaso gave a brief summary of Phase II of the Bond. NYS approved Phase II in late June making it difficult to begin work but work on the bathrooms will begin soon. Work on the science labs and HVAC cannot be done while school is in session and will begin the summer of 2016. Phase III has been sent to NYSED and will most likely be approved and begin also during the summer of 2016. It is anticipated that the EPC presentation will be submitted to NYSED in November. The district is incorporating LED lighting throughout the district and that work will begin this fall.

Mr. DeTommaso stated Bellmore-Merrick had an outstanding academic year. In keeping with the district's mission, "for kids and about kids," Mr. Seinfeld will give a brief presentation on the 2014-2015 year.

DATA PRESENTATION

Mr. Seinfeld began by stating these results include the summer school grades. He congratulated Ms. Ellinghaus and her team on their incredible work and the summer school students' remarkable achievements. His presentation will be posted on the district website tomorrow, September 3, 2015. He stated there was a tremendous drop in the number of students taking the assessments due to the Opt Out movement which did skew the results. In the case of the science regents, the district had a record number of students taking the test. The district's results were very good overall. In some areas the results were phenomenal and in other areas, there is room for improvement. The district will take advantage of its unique circumstances and schools with better results will share their insights. The district has good diploma rates and college bound statistics. He is interested to see how our inclusion students fare next year. He predicted an increase in the number of students enrolling in AP classes.
