The meeting was called to order at 8:25 p.m. Mrs. Goller, Board of Education President, led those present in the Pledge of Allegiance.

CALL TO ORDER

Mrs. Lanci moved that the Board of Education approve the minutes from the March 1 and March 20, 2017 meetings. Mrs. Piskin seconded and the motion was carried 7-0.

MINUTES

Mrs. Katz moved that the Board of Education approve the Treasurer's Report, Report, dated February 28, 2017. Mrs. DeLauter seconded and the motion was carried 7-0.

TREASURER'S REPORT

Mr. DeTommaso thanked everyone for coming as we celebrate another month of accomplishments in BMCHSD. Tonight we begin by recognizing the Calhoun Colts Cheerleading team as Nassau County champions.

SUPERINTENDENT'S REPORT

CALHOUN CHEERLEADING NASSAU COUNTY CHAMPIONS

Ms. Gargiulo stated The Calhoun Varsity Cheerleaders had an undefeated season which culminated in a Nassau County Championship win and a trip to the State Championship in Syracuse, New York. The team has 13 seniors and 10 first year varsity members. The majority of this team has worked together throughout their four years of high school where their skills have progressed with the growth of the program. They are new to the Co-Ed Division in Section 8 this year due to the addition of senior athletes, Christian Concepcion and Nick Cantalupo. This team was extremely motivated and dedicated to achieving their goal of competing in the State Championship and worked hard throughout the season training and conditioning to improve their skill level. It is an incredible achievement to become competitive with other teams in the county when this team only began We are extremely proud of their cheering competitively in high school. accomplishments this year and hope they continue representing Calhoun High School and the Bellmore-Merrick CHSD at this competitive level for years to come. Ms. Gargiulo, on behalf of the Board of Education, congratulated the team and their coaches.

COUNCIL OF ADMINISTRATORS ADMINISTRATORS AND SUPERVISORS (CAS) LIFETIME ACHIEVEMENT AWARD

Mr. DeTommaso stated we are always recognizing the incredible achievements of our students and staff. Tonight we recognize Kennedy High School Principal Lorraine Poppe. Ms. Poppe has been principal of JFK, one of the finest high schools in the nation, for 22 years. The Council of Administrators and Supervisors (CAS) have chosen Ms. Poppe for the Lifetime Achievement Award. No one deserves it more than Ms. Poppe.

Ms. Poppe thanked everyone and stated she loves coming to work every day and added that she is surrounded by wonderful people.

Mrs. Goller stated she was on the Board that hired Ms. Poppe and it has been a pleasure to watch her over the years. Ms. Poppe's commitment to the school community is visible and appreciated.

SUPERINTENDENT'S REPORT

Mr. DeTommaso stated that initially One Voice, One Message's (OVOM) objective was to bring the schools together. This program has expanded beyond that purpose. Dr. Bollettieri has been involved since the beginning. The OVOM Superhero 5K Run/Walk was held on Saturday, March 25th. He thanked all those involved in this event.

ONE VOICE, ONE MESSAGE SUPERHERO 5K RUN/WALK

Dr. Bollettieri stated the student ambassadors come up with the ideas. She introduced Robyn Einbinder and Joseph Netto who will give a recap of the Run/Walk. They, and many others, care so very much and Dr. Bollettieri thanked them all.

Mr. Netto stated there were 462 walkers/runners in the Third Annual OVOM Superhero 5K Run/Walk and many volunteers. Many in the community made donations. This event raised over \$10,000. A large portion of that money will go to "Rise Against Hunger" and \$1,500 will go to the Community Cupboard.

Alan Epstein is donating a sign for the Community Cupboard that reads "Community Cupboard – Families Helping Families."

PERSONNEL

Mr. DeTommaso announced the newly appointed principal of Mepham High School, Mr. Eric Gomez, adding that the building will be in very good hands. Mr. DeTommaso also introduced two new Special Education Chairs, John Jimenez at JFK and Maura Kempton at Grand Avenue. Mr. DeTommaso stated we need people who truly put kids first and it is a proud night when three fine educators become part of the leadership team.

Mrs. DeLauter moved that the Board of Education return to the order of the agenda. Mrs. Piskin seconded and the motion was carried 7-0.

RETURN TO ORDER OF THE AGENDA

Sara Samir congratulated the Cheerleading team. Calhoun students received 37 DECA medals at the State competition and will be going to nationals in two Weeks. Poseidon Pure placed in the top 15 at the Virtual Enterprise (VE) National Competition. Students traveled to Disney for a competition and the concert choir performed at Epcot. A Health Fair was held this past week. Seniors won Class Night and St. Baldrick's raised over \$32,000. The Senior Fashion Show is tomorrow night and those proceeds will go to "Reason to Smile." Relay for Life is scheduled for May 12th. "On The Town" musical production was very successful. Students discussed global issues at the recent Model UN trip. Honor societies held inductions this past month. Seniors are beginning to receive college acceptance letters.

Mr. DeTommaso added Sara Samir was a key component of Poseidon Pure's VE business plan presentation.

Sara Samir stated Poseidon Pure is a water filtration company.

Abigail Jellinek stated Kennedy's spring sports have begun. Kennedy students performed at Disney World. "Pippin" was very successful. A JFK student received an award at the Scholastic Art and Writing competition. The English Department raised \$4,000. Honor societies held inductions and a Health and Career Fair was very well received. Advanced Science Research (ASR) student continue to received more recognitions at the Long Island Science and Engineering Fair. A student's research has been published. A student won at a recent Poetry contest and another student's artwork will be displayed in the Heckscher Museum. The Senior Fashion Show was held last week and the proceeds will be donated. Kennedy students are participating in the "One Book, One New York" campaign.

Derek Baumann stated MAP held a Career Day at the beginning of the month. On March 17th, MAP students attended a Seal Watch boat trip from the Nautical Mile. He mentioned the OVOM Run/Walk and added it was a huge success. On the 24th of March students attended a modern take on Shakespeare's "Comedy of Errors" and held a Shakespeare Festival on March 31st. "Soles for Souls" is a community service project and they will accept gently used and new shoes all month in MAP. Mr. DeTommaso donated his shoes.

Madison Uzwy stated honor societies held inductions. Mepham's VE team took 2nd place at the Annual New York City Trade Show. She highlighted the OVOM Superhero 5K Run/Walk. Mepham's production of "Thoroughly Modern Millie" was a great success. Mepham's St. Baldrick's event raised over \$40,000 for children's cancer research. Mepham had 2017 Cultural Arts winners. Mepham's Elite after school activities explored last month. Mepham Kickline is hosting "So They Think They Can Dance" tomorrow night. The track team will be hosting the annual Paul Limmer event and students continue to support the Community Cupboard. Spring concerts will take place after the break.

Mr. DeTommaso stated all the plays were incredible. He found the Shakespeare Festival to be a very cool educational experience and requested a copy of the video.

SUPERINTENDENT'S REPORT

Mr. DeTommaso stated over 70% of Bellmore-Merrick parents have opted out of the English Language Arts (ELA) Assessments. This parental movement will continue until NYS works on these tests. Bellmore-Merrick assesses our students every day. One test does not measure the success of our kids. We have a true picture of how our students are doing. The Math Assessments are scheduled for May. Our students are receiving college acceptance letters from the schools they want to attend. The Class of 2017 is a high performing, top of the line class with amazing acceptance rates. There was a Community Forum held earlier tonight concerning the sale of the Jerusalem Avenue property. The Board will consider comments and suggestions made at tonight's meeting. No Board action will be taken tonight and information about another possible Community Forum will be forthcoming. A May 19th Realtor Breakfast at Brookside, showcasing what Bellmore-Merrick CHSD is about, may include CHAMP and Broadcast students.

Mrs. Freeman, Assistant Superintendent of Business gave a PowerPoint Budget presentation. This budget will retain all program and includes new initiatives. The 2013 Bond work is approximately half complete. Phase 3 is anticipated to be completed next year and Phase 4 is awaiting state approval. The district received a Aal Moody's rating in July, which contributed to the District obtaining a 2% interest rate on the BOND as well as the EPC, saving the District millions of dollars in interest payments. The full impact of Debt Service as well as health insurance increases of 12% for both 2017 and 2018 significantly impact the proposed budget. State aid is not finalized at this time. Additional aid may be used to impact the tax levy, which is now 3.23%. Federal aid cuts to Title grants could also impact the budget. CPI is 1.26%. The District will use reserves and fund balance to offset the budget.

ADOPTION OF BUDGET RESOLUTIONS PROPOSITION NO. 1 - CENTRAL HIGH SCHOOL DISTRICT BUDGET

RESOLVED, that the Board of Education of the Bellmore-Merrick Central High School District, Town of Hempstead, County of Nassau, is authorized to expend the sums in the General Fund Appropriate of one hundred fifty three million, six hundred sixty six thousand, eight hundred sixty three dollars (\$153,666,863)to be raised through taxation in the several districts included within the Central High School District after first deducting the monies available from state aid and other sources.

Ms. Gargiulo seconded and the motion was carried 7-0.

Ms. Gargiulo moved that the Board of Education approve the following resolution:

PROPOSITION NO. II - CAPITAL IMPROVEMENT PROJECTS

BE IT RESOLVED, that the Board of Education of the Bellmore-Merrick Central High School District, Town of Hempstead, County of Nassau, is hereby authorized to expend the sum of one million five hundred fifteen thousand and fifty four dollars (\$1,515,054) representing Capital Reserve Fund monies for the following purposes: districtwide paving and concrete work, track resurfacing, floor and ceiling tile replacement, roof replacement and/or resurfacing, tennis court refurbishment, turf replacement, door replacement, abatements, electrical and plumbing upgrades, fuel tank replacement and related work, structural work (brick, concrete and steel) and ADA compliance. Since the funds to be expended hereunder come from the Capital Reserve Fund, approval of this proposition will not require a tax levy upon the real property of the district. This Proposition shall be independent of Proposition No. I.

WHEREAS, the public school districts and the BOCES have agreed to form a Cooperative (the "Cooperative") for this purpose;

WHEREAS, the Bellmore-Merrick Central High School District is desirous of participating in the Cooperative for joint solicitation of proposals for pupil transportation services as authorized by General Municipal Law, Section 119-0 in accordance with the terms and conditions of the Inter-Municipal Cooperative Transportation Agreement attached hereto:

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education authorizes the School District to participate in the Cooperative; and

BE IT FURTHER RESOLVED, that the Board of Education hereby approves the Inter-Municipal Cooperative Transportation Agreement attached hereto and authorizes the Board President to execute the Agreement on behalf of the Board of Education.

BE IT RESOLVED, that the Board of Education approve an Inter-Municipal Transportation Management Services agreement between Bellmore-Merrick Central HS District, the Bellmore UFSD, the Merrick UFSD, the North Bellmore MANAGEMENT UFSD and the North Merrick UFSD authorizing inter-municipal cooperation and assistance with and among each other for the consolidation of their transportation management services and administration of the transportation management by a single transportation coordinator for the 2017-18 school year.

INTER-MUNICIPAL TRANSPORTATION

BE IT RESOLVED, that the Board of Education of the Bellmore-Merrick Central High School District approve the provision of bus transportation to particular non-public schools for a period of three years starting with the 2016-17 school year. BE IT RESOLVED, that the Board of Education approve the establishment of the Mobius Arts Scholarship for two (2) Mepham students in the amount of \$10,000 each funded by Dr. Mark Mobius. A committee will determine the recipients and the scholarship will be awarded at the Senior Awards Program.

SCHOLARSHIP

BE IT RESOLVED, that the Board of Education approve the hiring of a consultant, Steve Rodman Entertainment, to perform/educate as part of Mepham's ELITE Program Math and Magic on 3/15/17 at a total cost of \$125 to be funded by G.O. account.

Dr. Kaplan seconded and the motion was carried 7-0.

Ms. Gargiulo acknowledge the large and generous scholarship financed by Mr. Mobias. Michael Harrington, Principal of Mepham High School, stated Mr. Mobias is a graduate of Mepham HS, Class of 1954. He is an international investor and founded the firm Templeton Investments. He and his year have been very generous over the years. Some lucky students will truly appreciate receiving this scholarship.
