I. CALL TO ORDER

The meeting was called to order by Ms. Lanci, Board of Education President at 8:09 p.m.

Mr. Corona stated that Senya earned the highest GPA in her class, calculated to a 101.68 weighted average through her junior year. Her transcript boasts Advanced Placement courses in nearly every subject area with a concentration in the math and science departments. Her ever growing thirst for knowledge coupled with her desire to remain socially connected has made her more than just our Valedictorian; she is also a leader who reaches out to students of all abilities. Senya would like to pursue a major in either Oncology or Neonatology and will attend Hofstra in the fall as a member of the 4+4 medical school pathway.

BE IT RESOLVED, that the Board of Education authorize a transfer of an amount not to exceed two million dollars (\$2,000,000) from fund balance of the General Fund as of June 30, 2019 to the Retirement Contribution Reserve (GML §6-r, 3(a)), and

BE IT RESOLVED, that the Board of Education authorize a transfer of an amount not to exceed one million three hundred thousand dollars (\$1,300,000) from fund balance of the General Fund as of June 30, 2019 to the Retirement Contribution Reserve Sub-Fund (New York State Teachers (GML 6-r,). and

BE IT FURTHER RESOLVED, that the Board of Education authorize a transfer of an amount not to exceed two million dollars (\$2,000,000) from fund balance of the General Fund as of June 30, 2019 to the Employee Benefits Accrued Liability Reserve (GML §6-p, 3(a)), and

BE IT FURTHER RESOLVED, that the Board of Education authorize a transfer of an amount not to exceed six hundred thousand dollars (\$600,000)¹ from fund balance of the General Fund as of June 30, 2019 to the Workers Compensation Reserve (GML §6-j, 2(a)).

V. Reimbursement for Attendance Functions

WHEREAS, Board Policy 6830 permits school district employees, officials and members of the Board of Education to be reimbursed for reasonable, actual and necessary out of pocket expenses which are legally authorized and incurred while traveling for school related activities; and

WHEREAS, the Superintendent of Schools determined that Central Office Administrators were required to attend certain functions in the best interest of the School District, including the BMUST Retirement/Annual Dinner, Nassau BOCES Awards Dinner, PTA Founders Day, Cultural Arts Luncheon, JFK Hall of Fame Awards Dinner; and

WHEREAS, members of the Board of Education in the best interest of the School District also attended such functions; and

WHEREAS, Central Office Administrators and Board Members attended and paid for said events; and

WHEREAS, such expenses are eligible for reimbursement, pursuant to Board Policy 6830.

NOW THEREFORE BE IT RESOLVED, that the Board of Education authorizes reimbursement to Central Office Administration and Board members for their attendance at said events; and

THEREFORE BE IT FURTHER RESOLVED that the Board of Education authorizes the Assistant Superintendent of Business or her designee to process said reimbursement.

W. Summer Recreation Agreement

BE IT RESOLVED, that the Board of Education approve an agreement with Summer Camp of Bellmore-Merrick, Corp. for the lease of space at Merrick Avenue Middle School for the operation of a summer recreation program for the period July 1, 2019 through August 2, 2019, at a cost of \$62.50 per child per session.

X. CORRESPONDENCE

Ms. Lanci stated we did receive correspondence.

XI. PUBLIC COMMENTS

Connor Desmond spoke about the conjoining and combination of the arts program in Kennedy High School. He stated that combining the classes could lessen the experience for the student. Mr. DeTommaso said that we put a lot of effort into the Arts and we love to run individual courses but a lot depends on the enrollment. He said that he will have Cheryl Fontana, Director of Fine and Performing arts look into it.

Aaron Goldsmith wanted to discuss a private matter with the Board of Education and was addressed by counsel Chris Powers. Mr. Harrington was instructed to update the parent after discussion in executive session.

Hali Herman thanked the Board of Education for their dedication, commitment, and pride in our district. She said that the Board of Education does a lot that other district don't do and she thanked the members for their dedication to the students. She also thanked Ms. Hollings who she called "just awesome".
