X. MOTION TO CONVENE PUBLIC HEARING – SCHOOL SAFETY PLANS On a MOTION by Mr. Ferrara seconded by Ms. Piskin and passed 7-0, the Board of Education convened into Public Hearing for the School Safety Plans.

Ms. Freeman gave a Power Point Presentation about the School Safety Plans. She explained that NYS requires that the District have two types of Safety Plans, a district-wide safety plan and building-level safety plans which detail how to react in case of an emergency. Ms. Freeman explained that last month the Board of Education reviewed both plans for the 2019-2020 school year and made the district-wide plan available for public comment and review. The building-level plan is confidential and was not made available to the public. Ms Freeman said that Jon Simpkins was appointed as the Chief Emergency Officer and a safety team was assigned as stated in the plans. Once adopted, these plans will be filed with the New York State Department of Education and shared with law enforcement.

Mr. DeTommaso explained that some districts have recently been audited by the NYS Comptroller regarding these safety plans. He explained that these plans are part of school safety in that they are they paperwork aspect of the plan. While some schools haven't followed through with filing of documents in their plan, it is no reflection on the safety in the school. Mr. DeTommaso stated that our district has been on top of this issue and he thanked Mr. Simpkins for a job well done.

Dr. Kaplan stated that she is currently serving as a grant reviewer for the NYS Department of Education and that while Bellmore-Merrick CHSD does not qualify for the grants she has been reviewing, she is very impressed by what this district has accomplished without funding.

Ms. Blane asked if there were any public comments and there were none.

On a MOTION by Ms. Lanci seconded by Mr. Ferrara and passed 7-0, the Board of Education approved the following motion:

A. School Safety Plans

BE IT RESOLVED, that the Board of Education adopts the district-wide and building-level safety plans and directs that the district-wide plan be filed with the Commissioner of Education within 30 days of the adoption of this Resolution
