Mr. DeTommaso welcomed the student representatives and said that tonight we will recognize students and staff for their achievements.

# 2019 Broadcom MASTERS National Finalists

Tyler Bissoondial was not present to accept his Award of Honor certificate. Mr. DeTommaso congratulated him on his work.

### 2019 Broadcom MASTERS National Semifinalists

Mr. Corona presented Adhith Jacob and Dillon Moi with Award of Honor certificates for their research project entitled "Is It Possible to Create a More Functional Smartwatch?". For their project, they designed a smart watch that is more user friendly with more functions then watches currently on the market.

Rob Soel gave a brief explanation about the STEM Program and explained that the district now offers coding and robotics.

#### XI. PUBLIC COMMENTS

Lisa Derwin wanted to discuss transportation for her child.

Rania Elbaz requested that EID holidays be added to the school calendar and asked if it will be placed on an upcoming agenda and discussed in public. She further questioned why the school district is closed on the Wednesday before Thanksgiving. Mr. DeTommaso explained that the school calendar will be discussed in December and the public will be able to comment. He further explained that every year the calendar changes and that the Wednesday before Thanksgiving is not guaranteed going forward.

Mr. Powers explained that NYS Education Law section 3210 states the Board of Education or trustees shall determine whether school session should not be held at an individual public school, or district-wide, on a day where, if school were in session, absenteeism may result in the waste of educational resources because a considerable proportion of the student population is unlikely to attend because of a religious or cultural day of observance. He further explained that this district's determination is not binding of another school district and that a lot has to do with the community and population in making a decision.

Arooj Iqbal requested that EID holidays be added to the school calendar so when her child attends this district EID will be an official holiday.

Mr. DeTommaso explained to Ms. Umar that whether the Board passes this or not, the district does care about families and kids and said the Board will look at the calendar in December.

Aya Elsayed asked if there has been a survey about EID holidays. Mr. DeTommaso said did not do a survey but stated that they will look at attendance records from previous holidays, taking into consideration that some students may have chosen to attend school.

Mr. DeTommaso congratulated Mr. Caballero for organizing the Excellence in Performance Program attended by all the athletes and their parents. He said the program delivered an important message to the parents and athletes.
