#### V. SUPERINTENDENT'S REPORT

## A. **Presentations**

Mr. Harrington welcomed everyone to the meeting and changed the order of the Superintendent's report.

#### Annual External Audit Review

Alan Yu of Cullen and Danowski, LLP gave a presentation on their audit of the Bellmore-Merrick Central High School District's finances ending June 30, 2022, which had an operating deficit of five million dollars. He was pleased to report that there are no reportable findings and the District's financial health is consistent. He added that the District maintains a strong fund balance that is on par with other districts. He reported that most of the previous recommendations were positively implemented. They found no material weaknesses, clean internal controls and a said this is a very positive report.

#### School Board Recognition

Mr. Harrington said it has been an unbelievable month. He said that 56 musicians became All-County and will perform in NYSSMA. He said many of the sports teams made playoffs and that the swim team won the division championship and the Calhoun Cross Country team won the county championship.

Mr. Harrington said that November is when we get to honor our Board of Education. He said that this school district would not be able to accomplish all that it does without this incredible board. He explained that by serving on the high school board, these board members have committed to serving on two Boards of Education. He said they make smart decisions and we are in a great place because of them. Mr. Harrington congratulated Ms. Piskin on being chosen for the 2022 Women of Distinction award and said she was recently honored at a dinner with State Legislator Dave McDonough.

Ms. Fontana thanked the Board of Education for the countless hours of time they have given to our students and community. She said our board members are dedicated and caring, always making decisions that are best for our kids and always support the music and art programs.

Merrick Avenue and Grand Avenue Middle School art students presented the Board of Education with a collaborated art piece, depicting the cover of the book "What the Road Said" by Cleo Wade, which coincides with this year's theme of "Pathways, Path, Purpose".

Prep Academy Art 3 students presented the Board of Education with an art piece that was made by combining pieces from each student to form one picture of their school mascot, a husky.

Kennedy High School students "JFK Voices" gave a musical performance of "Can't Help Falling in Love" to the Board of Education in honor of their dedication to the school community.

#### Curriculum and Instruction - Cosmetology Program

Mr. Melkonian said cosmetology students are learning state-of-the-art trends in styling, hair coloring, nail enhancement, and skin care and have the opportunity to turn their passion into a lifelong career. He welcomed the students of the cosmetology program, teacher Ms. Pendl and our partners, staff from De La Mer Salon & Spa to give a presentation to the Board of Education. They thanked the Board of Education for their support of the program and the renovations to the salon at Calhoun High School. The students showed the audience how to create a beach wave hairstyle on a mannequin while the staff of De La Mer Salon & Spa explained the program. They explained that students are not only learning techniques, they are learning the business side, networking and marketing skills. In honor of Board Appreciation Month, the Board of Education was offered free salon services by the students.

Mr. Harrington thanked them for the demonstration and said the adults working in the program have vision, which develops passionate learners and gives students a pathway and purpose.

Ms. Piskin said she loves that the students are learning the entire business and Dr. Kaplan thanked De La Mer Salon & Spa for their support in the community.

## **Student Representatives**

Jordan Nelson from the Meadowbrook Alternative Program/Prep Academy and Electrical Training program said students are still enjoying the surfing program. The said that Brookside celebrated Halloween with costumes and a parade followed by Sprit Week. Jordan also mentioned the Multi-Faith Assembly and picture day. He thanked the North Merrick School District and Mepham High School for hosting Trunk or Treat with proceeds benefiting the Community Cupboard. He said students are looking forward to welcoming veterans, as they will be coming to Brookside for a presentation on November 10<sup>th</sup> for Veteran's Day.

Nicole Giordano (filling in for Rachel Oppenheim) from Kennedy High School said the past month has been just as exciting as the first. They held a fun and energetic safe Halloween last week with costumes and dancing. Next week they will have Academic Field Day where students will attend workshops held by their teachers so they can all connect on a different level. She said the senior class sold breast cancer awareness shirts and raised over \$1500.00 to benefit Susan G. Komen for the Cure. Lastly, she congratulated the inductees to the Word Language and Math Honors Societies and said it was her pleasure to be here tonight.

Sophia Tripiccione from Calhoun High School said that they had a very successful "Pink Out" senior game and sold shirts to raise money for the Breast Cancer Research Foundation. She said the football team made it to the playoffs and both the boys and girls volleyball teams are in the playoffs. Sophia also mentioned that On Tour will be showing their play King Lear this week. Lastly, she talked about the Halloween Dance for the Special Education program and said on Halloween they had a costume contest to raise money for the Music Never Stops: Tyler Seaman Foundation.

## D. NFHS Network School Broadcast Program

BE IT RESOLVED, that the Board of Education approve a contract with NFHS School Broadcast Program, powered by 2080 Media, Inc. d/b/a Play On! Sports, for livestreaming services of Bellmore-Merrick CHSD sporting events on our home fields for the 2022-23 school year at a cost of \$9,000.00.

## E. Eastern Suffolk BOCES Joint Municipal Cooperative Bidding Program

WHEREAS, various educational and municipal corporations located within the State of New York desire to bid jointly for generally needed services and standardized supply and equipment items; and

WHEREAS, the Bellmore-Merrick Central High School District, an educational/municipal corporation (hereinafter the "Participant") is desirous of selectively participating with other educational and/or municipal corporations in the State of New York in joint bidding in the areas mentioned above pursuant to General Municipal Law § 119-o and Education Law Section 1950; and

WHEREAS, the Participant is a municipality within the meaning of General Municipal Law § 119-n and is eligible to participate in the Board of Cooperative Educational Services, First Supervisory District of Suffolk County (hereinafter Eastern Suffolk BOCES) Joint Municipal Cooperative Bidding Program (hereinafter the "Program") in the areas mentioned above; and

WHEREAS, the Participant acknowledges receipt of the Program description inclusive of Eastern Suffolk BOCES' standard bid packet and the general conditions relating to said Program; and

WHEREAS, with respect to all activities conducted by the Program, the Participant wishes to delegate to Eastern Suffolk BOCES the responsibility for drafting of bid specifications, advertising for bids, accepting and opening bids, tabulating bids, awarding the bids, and reporting the results to the Participant.

BE IT RESOLVED that the Participant hereby appoints Eastern Suffolk BOCES to represent it and to act as the lead agent in all matters related to the Program as described above; and

BE IT FURTHER RESOLVED that the Participant hereby authorizes Eastern Suffolk BOCES to place all legal advertisements for any required cooperative bidding in <u>Newsday</u>, which is designated as the official newspaper for the Program; and

BE IT FURTHER RESOLVED that a Participant Meeting shall be held annually consisting of a representative from each Program Participant. Notice of the meeting shall be given to each representative at least five (5) days prior to such meeting; and

BE IT FURTHER RESOLVED that an Advisory Committee will be formed consisting of five to ten representatives of Program Participants for a term of three (3) years as authorized by General Municipal Law §119-o.2.j.

BE IT FURTHER RESOLVED that this Agreement with the Participant shall be for a term of one (1) year as authorized by General Municipal Law §119-o.2.j.

BE IT FURTHER RESOLVED that the Participant agrees to pay Eastern Suffolk BOCES an annual fee as determined annually by Eastern Suffolk BOCES to act as the lead agent for the Program.

#### F. Reserve Funds

WHEREAS, at its June 1, 2022, Board of Education Meeting, the Board of Education authorized a transfer of an amount not to exceed two million five hundred thousand dollars (\$2,500,000) from fund balance of the General Fund as of June 30, 2022, to the Capital Reserve (ED LAW §3651); and

WHEREAS, at its June 1, 2022, Board of Education Meeting, the Board of Education authorized a transfer of an amount not to exceed one million five hundred thousand dollars (\$1,500,000) from fund balance of the General Fund as of June 30, 2022 to the Retirement Contribution Reserve Sub-Fund (New York State Teachers (GML 6-r,); and

WHEREAS, the Board of Education has determined the actual amounts that are being transferred from the General Fund to these funds specified herein; now

BE IT RESOLVED, that the Board of Education authorize a transfer of one million five hundred thousand dollars (\$1,500,000) from fund balance of the General Fund as of June 30, 2022 to the existing Capital Reserve (ED LAW §3651), and

BE IT RESOLVED, that the Board of Education authorize a transfer of eight hundred seventy eight thousand fifty four (\$878,053) from fund balance of the General Fund as of June 30, 2022 to the existing Retirement Contribution Reserve Sub-Fund (New York State Teachers (GML 6-r,)
