The meeting was called to order at 8:08p.m. Dr. Kaplan, Board of Education Vice President, led those present in the Pledge of Allegiance. Dr. Kaplan welcomed everyone.

Mrs. DeLauter moved that the Board of Education approve the minutes from the November 2, 2016 and the November 29, 2016 meetings. Ms. Gargiulo seconded and the motion was carried 6-0

Mrs. Lanci moved that the Board of Education approve the Treasurer's Report, dated October 31, 2016. Mrs. Blane seconded and the motion was carried 6-0.

Sara Samir of Calhoun High School congratulated both Calhoun Boys Soccer and Kennedy Boys Volleyball teams for becoming champions, their coaches for being named Nassau County Coaches of the Year and team members named All Conference, All State and All Long Island. Mr. DeTommaso mentioned students from all the buildings performed in the District Choral Show. Additionally, before intra district teams play, we will take a photograph of the teams together. Kennedy's and Calhoun's girls basketball game was the first.

Abigail Jellinek of Kennedy congratulated coaches teams and outstanding athletes for their achievements. She stated all Kennedy's teams are scholar athlete teams. A Blood Drive netted 25 pints of blood. MAP students are accepting donations for the Community Cupboard.

Mr. DeTommaso stated he received a letter from a senior citizen thanking him for the Senior Citizens Connection newsletter that notifies the community of upcoming events.

Madison Uzwy of Mepham High School stated the entire community enjoyed Mepham's recent TEDx event. She thanked the sponsors. Students donated 131 pints of blood. Community Leadership students escorted elderly veterans through a series of stations distributing supplies. Alumni Day was very successful. A 2017 Science Competition (Intel) celebration was held last month. Students continue work with Habitat for Humanity. All sports teams are Scholar Athlete teams. The drama production, "The Government Inspector" was a great hit. Battle of the Classes was close. Mr. DeTommaso mentioned that Mepham's football team received the Nassau County Community Service Award. He also noted some important up-coming dates.

SUPERINTENDENT'S **REPORT**

He stated earlier tonight we recognized Kennedy's Volleyball team as the Conference and Nassau County champions for the second consecutive year and Calhoun's Soccer team as the Conference, Nassau County and Long Island champions. The Colts played great at the State Final Four in Middletown, NY but lost to eventual champion New Rochelle by a score of 4-3. It was a season that none will ever forget. Both teams' coaches were named a Nassau County Coach of the Year.

Mr. DeTommaso stated about three weeks ago, the district was advised of a threat made to all Nassau County schools. After consulting with the component districts, all five districts sent messages to all parents and staff advising them of this non-specific threat. Not all districts in Nassau County did but we are concerned with the safety of our students and felt notification was important. We have reviewed our notification methods and will make adjustments to the way people are notified.

Mr. DeTommaso also mentioned the inaccuracies in Newsday's recent article regarding Bellmore-Merrick CHSD's State Audit and urged everyone to go to the district website to read the district's response to the state. The district is in excellent fiscal condition, recently received a Bond Rating of Aa1 and approved for a loan interest rate of 2% which will save the district more than \$10 million dollars over the next 15 years. Mrs. Freeman, Assistant Superintendent for Business, explained the state's headline of \$21 million dollars is a distortion and really is the same \$7 million a year for the last three years. This money is set aside for emergencies such as roof and boiler replacements, and unexpected increases in Social Security, TRS, which rose 4% or \$3 million in 2012-2013, and ERS payments. Each year, any remaining funds have been applied to the next year's budget. Tonight the Board will re-establishing the Unemployment and Workmen's Compensation Reserve Funds.

CONSTRUCTION CHANGE ORDERS

UNEMPLOYMENT RESERVE FUND

BE IT RESOLVED, by the Bellmore-Merrick Central High School District Board of Education pursuant to Section 6-m of the General Municipal Law:

- 1. The Board hereby establishes a reserve fund to be known as the Unemployment Reserve Fund;
- 2. The source of funds for this reserve fund shall be any funds that may be legally appropriated;
- 3. The balance of this reserve fund shall not exceed \$350,000;
- 4. Expenditures shall be made from this reserve fund only as required by law to pay into the unemployment insurance fund an amount equivalent to the amount of benefits paid to claimants and charged to the school district.

WORKMEN'S COMPENSATION RESERVE FUND

BE IT RESOLVED, by the Bellmore-Merrick Central High School District Board of Education pursuant to Section 6-j of the General Municipal Law:

- 1. The Board hereby establishes a reserve fund to be known as the Workmen's Compensation Reserve Fund;
- 2. The source of funds for this reserve fund shall be any funds that may be legally appropriated;
- 3. The balance of this reserve fund shall not exceed \$750,000;
- 4. Expenditures shall be made from this reserve fund only for the payment of compensation and benefits, medical, hospital or other expense authorized by article two of the workmen's compensation law and expenses of administering the self-insurance program.

WHEREAS, that the Board of Education PREVIOUSLY ESTABLISHED RESERVES FOR Workers' Compensation and Unemployment Insurance; and

WHEREAS, the Board of Education has reviewed said reserves for compliance with law;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby reauthorizes the establishment of said reserves and affirms that the following amounts were previously authorized for transfer into said reserve funds: Workers' Compensation Reserve: \$9,750

ATTENDANCE FUNCTION

BE IT RESOLVED, that the following members of the Board of Education are approved to attend the Council of PTAs Founders Day Dinner at the Coral House on March 13, 2017 at a cost of \$47.00 per person.

TRANSPORTATION CONTRACT EXTENSION

BE IT RESOLVED, that the Board of Education approve the extension of school bus transportation contracts with Guardian Bus Company, Inc. for a one (1) year period for the School Year 2016-17 at full C.P.I., and, as has been done for prior extensions, continue the waiver of the performance bond for the period of the contract extensions. Extension parameters listed include large bus and van contracts in all categories, athletic and charter trips to be included.
