Ms. Blane, Board President called the meeting to order at 6:32 p.m.

EXECUTIVE SESSION

On a **MOTION** by Ms. Lanci, seconded by Ms. Miller and carried 7-0, the Board of Education entered into executive session to discuss a personnel matter.

On a **MOTION** by Ms. Goller seconded by Mr. Corona and carried 7-0, the Board of Education reconvened into public session at 8:06 p.m.

V. SUPERINTENDENT'S REPORT

Mr. DeTommaso welcomed everyone. He said tonight, once again, is a night of champions in the Central High School District. He said we recognize three students tonight for their achievements in the Regeneron Science Competition. Mr. DeTommaso explained how incredible this accomplishment is and congratulated the students, their teachers and their parents.

Regeneron Science Competition Scholars

Ms. Goller presented and Award of Honor certificate to Andrew Brinton from Kennedy High School. Ms. Goller congratulated Andrew on his research project entitled "Marsh Restoration: Ribbed Mussels (Geukensia demissa) as a Revival Mechanism to Rebuild the Coastal Salt Marshes of Long Island, New York" and said he is bright, inquisitive, disciplined and kind.

Kenar Gelman from Kennedy High School was not present to accept her Award of Honor certificate. Mr. DeTommaso congratulated Kenar on her research project entitled "Chondrocyte Adenosine A2A Receptor Signaling Leads to Cellular Homeostasis Through Activation of Protein Kinase A (PKA)".

Ms. Piskin presented an Award of Honor certificate to Katherine St. George from Kennedy High School. Ms. Piskin congratulated Katherine on her research project entitled "The Ketogenic Diet Ameliorates: The Effect of Caffeine in Seizure Susceptible Drosophila melanogaster" and said she continues to impress peers and faculty at every turn.

Mr. DeTommaso again congratulated the students, Barbi Frank and Bobby Zinke. Mr. Zinke was recognized by his former student Katherine St. George in her research project.

Mr. DeTommaso discussed the STEAM program and how it is expanding opportunities for kids. He said that Kennedy High School hosted the first Robotics competition that drew about 40 teams from Long Island and beyond. Mr. Soel said the middle schools would be competing in robotics and other science competitions.

Mr. DeTommaso said that this district does not focus on what the kids decide to take; it is about the opportunities that are offered to them. He mentioned the strong business programs in the district and how the Bellmore-Merrick Challenge was a great opportunity for the students to team up with students from our other schools. Local universities and their business programs were on hand throughout the day.

Mr. DeTommaso said the district is getting close to piloting the Prep Academy and he thanked Mr. Arlin and Ms. Paluseo. The district has partnered with three great organizations, CMA, Life's WORC and FREE for the program. He said the Prep Academy would allow students graduating from Calhoun to come to Brookside to prepare them for the next step in their development, offering students expanded opportunities for work and life after school.

Mr. DeTommaso thanked Ms. Fontana for organizing the Faculty Follies. He said it really does not have many follies because every act is fantastic. He said the community came together for the Community Cupboard and raised \$3,060.00. Mr. DeTommaso also said the Faculty Follies gives students the chance to see their teachers and staff outside of how they usually see them. The students take great pride in seeing their teachers doing the things that they also like to do. Mr. DeTommaso thanked everyone involved for putting together an amazing show.

Mr. DeTommaso congratulated Ms. Freeman on her upcoming retirement and said she has done an amazing job for the last three years. Mr. DeTommaso said he was proud to announce that Ms. Coni will be appointed as Assistant Superintendent for Business starting July 1, 2020.

Student Representatives

Gabriella Giobardo said that Calhoun High School had an eventful and successful January. She said that the On Tour program produced the comedy "Once in a Lifetime" and is currently rehearsing "The Secret Garden" for production in March. She said the Science Olympiad had medalists in six categories last Saturday. She also said the Calhoun Sports teams did very well last month, especially the basketball, bowling, wrestling, swim teams and track. Gabriella said she spoke on the coalition panel "Vapes and Vaping" to raise awareness about the vaping crisis and hopes the number of students vaping will reduce. She also spoke about the new club called COPE which stands for Cooperatively Overcoming Problems Effectively. COPE is a student-led initiative that focuses on breaking the stigma around mental health in a for-youth, by-youth environment.

Mr. DeTommaso said Gabriella did a great job speaking on the panel about the vaping problem. He said that vaping is something that needs to be focused on and that the information from police, TEMPO, NYU Langone and students who spoke on the panel was very enlightening, especially from the kids.

Daniel Iskols said he was proud to share that Kennedy High School's Senior Cyber Patriot team placed first in NYS in the Platinum tier for the second year in a row. Kennedy hosted its annual Alumni Day and a VEX robotics competition, adding that both events were a huge success. He congratulated the Regeneron Scholars and the basketball team and said that everyone had a great time at the Jam the Gym event.

Mariana Mora from Meadowbrook Alternative Learning Program (MAP) said since our December meeting, students enjoyed a bowling trip and a badminton tournament with faculty. They also had field trips to the NY Hall of Science, Canine Companions and the Tilles Center. MAP students also enjoyed a cultural sensitivity workshop and a discussion series called "Life After High School". Mariana said that MAP students also participated in the "Vapes and Vaping" panel discussion.

Mr. DeTommaso congratulated Mariana Mora for doing a great job with the vaping panel. He feels it was very important that all of the schools were represented and participated in the event.

Stefanie Simone said Mepham High School had an exciting month. Students enjoyed the Mr. Mepham pageant and assembled 300 bags of seasonal supplies for various shelters for the MLK Day of Service. She congratulated two PTA Reflections entry winners, the Future Business Leaders of America Club Regional Conference winners. She also congratulated science teacher Mrs. Parlagreco, who received the Zagarino Outstanding Community Member of the Year award from the Bellmore Chamber of Commerce. Stefanie also congratulated the Robotics team and sports teams for their accomplishments. She said upcoming Mepham would hold the "Forever Teal Blue" event to honor 2011 graduate Kayla Donnelly-Smith who passed away in 2015. She asked everyone for their support and said all proceeds from the event will go to the Kayla Donnelly-Smith Memorial Scholarship.

Mr. DeTommaso said the MLK Day of Service was a great success, every school participated and many supplies were donated. Dr. Bollettieri said hundreds of bags were donated to eight different shelters.
